REVIEW OF UNSW FOUNDATION STUDIES ENGLISH ENTRY REQUIREMENTS

Following a thorough review of student performance in UNSW Foundation Studies programs, a number of changes have been made to English entry requirements for most programs. Revised English language requirements appear in the tables below, with changes highlighted in **red**. All changes are effective from **22 February 2018**.
