New students who use Green River's I-20 to enter the U.S.A. must: Report in person to Green River's orientation session for new international students; Enroll for and attend the first quarter at Green River; Carry Health Insurance while enrolled at Green River; Present originals of: passport, visa, and Green River's I-20 - Students transferring from other U.S. schools must present their most recent I-20.

### **Medical Release**

The undersigned hereby gives to Green River Community College, its officers, employees, agents, and host families full authority and permission to take whatever action they feel is reasonably warranted under the circumstances, and to act as agent of the undersigned student and parent/guardian, regarding the named student's health and safety.
