

GENUINE TEMPORARY ENTRANT (GTE) APPLICANT ASSESSMENT FORM

Kaplan International English requires Education Agents to implement the following process when recruiting international students for study at Kaplan International English. - 4. The applicant must sign and date the Student Declaration upon completion of the interview
- 5. The Education Agent must complete, sign, and date the Risk Assessment & Recommendation
- 6. The Education Agent must forward a copy of the completed Applicant Assessment Form with the student's application to the admissions team at Kaplan International English
