Regional Scholarship Eligibility Criteria

To be eligible for the Regional Scholarship, you must:

1. Hold citizenship from Asia.
2. Have enrolled in full-time undergraduate or postgraduate study.
3. Have met Kaplan's academic requirements for the course offered.
4. Have met Kaplan's English language proficiency requirements for the course offered. NB: Students who are applying for a packaged offer with Kaplan International English, may be awarded a scholarship conditional upon satisfying the English Language requirements.
5. Demonstrate a fair level of academic success, with an average result of at least the equivalent of an Australian grade of 65% in the most recently completed prior studies. **Please note, the minimum requirement for each specific qualification will be determined by Kaplan Business School and may be higher than 65%.**
6. Complete a 250 word essay on "How a Kaplan degree will help you achieve success in the future".
7. Have enrolled in your Kaplan Business School course in Trimester 1, 2 or 3 of 2018 or Trimester 1 2019 (including students with Kaplan International English packages). Commencement may not be deferred beyond Trimester 1, 2019.
8. Not be a recipient of any other Kaplan Business School scholarship.
