## PROGRAM ENTRY REQUIREMENTS

Students must meet the following requirements for entry into CityU's DBA program.

- MBA or Business-related Master's degree, with minimum GPA of 3.0 or equivalent.
- Work experience highly recommended.
- English Proficiency: Standardized test scores such as TOEFL 87, IELTS 6.5, iTEP 4.5, or PTE 59 are accepted. Please consult [www.CityU.edu](http://www.CityU.edu) for full policy and other options for proof of proficiency.
- Interview with Associate Dean and DBA Program Director.

### Documentation:

Students must submit a Resume/CV, goal statement, and three professional references.

## APPLICATION REQUIREMENTS

1. International student application form
2. \$50 application fee
3. Original or certified copies of diplomas and transcripts (with certified English translations)
4. Proof of English language proficiency
5. Consent to release information (if applying through CityU's approved agents)
6. Bank statement and financial statement
7. Copy of passport
8. After arrival in the U.S.: Copies of I-94, visa, and entry stamp
