Academic requirement:

Minimum second class honours degree or equivalent.

English requirement:

Programme	English Requirement
MA/MSc	IELTS 6.0 (no element below 5.5)
MBA	IELTS 6.0 (no element below 5.5)
LLM	IELTS 6.5 (no element below 6.0)

Pre-Sessional English:

- September – December 2015
- For Degree programmes requiring 6.0, IELTS of 5.5 (4.0) is required
- For Degree programmes requiring 6.5, IELTS of 6.0 (4.5) is required
- Fee: £3,100

Scholarships:

Every international applicant will be automatically considered for a scholarship of up to £5,000.
